Irish Legal 100 Honors Glaser Weil Litigator Peter Sheridan for the Fifth Consecutive Year

Kennedy and Neil Gorsuch, and numerous other federal and state court judges, legal and business leaders from insurance, financial, energy and manufacturing companies around the world, and presidents, deans and professors from some of the most prestigious Universities and Law Schools in the world.
