

In 2005, MGM MIRAGE began to envision a "new" Las Vegas and turned to its long-time law firm Glaser Weil as legal counsel and advisor. The complexity and magnitude of CityCenter were matched by the speed the plans called for.

Glaser Weil partners Peter Weil and Carolyn Jordan went to work immediately, working with CityCenter executives to establish a framework and assemble the right team of professionals.

They developed the overall strategy for creating, negotiating and managing the volume of legal documentation associated with developing the multi-faceted project.

Every aspect of the enormous project coupled with an ambitious schedule brought its own unique hurdles.

Construction and Architecture

Glaser Weil's real estate department, led by Saul Breskal and Jerry Katz, negotiated and drafted more than 100 intricate design and construction-related contracts, along with scores of consultant agreements, involving some of the biggest and most renowned contractors, architects and design professionals in the world, including Perini, Tishman, Gensler, Caesar Pelli, Rafael Vinoly, Lord Foster, Daniel Liebskind, HKS, Adamson and more.

Considering the size and complexity of CityCenter, negotiation of these contracts required creativity and ingenuity in order to meet MGM MIRAGE's commitment to diversity and sustainability, and to address the limitations posed by Nevada law.

A Global Partnership

In 2007, MGM MIRAGE partnered with Dubai World and turned to Glaser Weil to create the legal and contractual framework of the joint venture, which involved Dubai World's acquisition of a 50% interest in CityCenter for \$2.7 billion.

Glaser Weil attorneys Peter Weil, Janet McCloud, Carolyn Jordan and Daniel Kim worked around-the-clock to negotiate and document the joint venture agreement, as well as the terms of the management and operations agreements. And at the same time they developed creative, legally sound solutions to obtain a multi-billion dollar title insurance package that tapped out the title insurance industry.

Financing

In the face of the global economic crisis, Glaser Weil, led by Carolyn Jordan, negotiated and documented a complicated \$1.8 billion credit facility from a consortium of eight lenders.

Environment/LEED

From the outset, MGM MIRAGE was committed to making CityCenter environmentally responsible and sustainable. To achieve this, Glaser Weil's Jerry Katz worked closely with the client's sustainability team to develop contract standards and provisions, communication protocols, risk analysis, and project management procedures, and the environmental group led by partner Terry Avchen addressed issues related to environmental compliance.

The result: one of the world's largest sustainable communities, from design and construction to operations and guest amenities. By its opening CityCenter had already received the highest Leadership in Energy and Environmental Design (LEED) rating of any hotel, retail district or residential development in Las Vegas.



Land Use

During 2006 and 2007, Las Vegas managing partner Jim Mace, along with Mandy Shavinsky and Carolyn Jordan, spearheaded the firm's work on the project's entitlements and the rules governing relationships within the CityCenter community. They overcame daunting land use and development hurdles, which resulted in, among other things, a novel three-dimensional mapping process allowing for future flexibility in acquisition and dispositions.
